 - i. LSU-BR Faculty Senate President Kevin Cope met with Interim President William Jenkins who reported surprised that things were worse than expected, regarding issues such as inequities in faculty compensation at different institutions; he suspects the search for a new President will be a slow process
 - ii. ORP per HB 1131, employer compensation will be reduced from 5.9 to 5.4% with the difference going to the unfunded liability
