## II. Council of Faculty Advisors Meeting- Senator Rubin

House Bill 68 failed. It would have tied the ORP to the new state retirement plan. The Board of Supervisors is fighting the public records request by the Baton Rouge Advocate.

Chancellor Hinesfield from Pennington was recently released.

Board of Supervisors Meeting

A number of faculty from LSU Baton Rouge gave public comment relating to a number of issues such as low pay for faculty, lack of raises for years, problems with hiring, retention and low morale.

There may be 10 million dollars available for general operating and maintenance across the LSU system. The health sciences center in Shreveport, specifically the school of allied health is getting exemptions for out of state tuition for help in recruiting. All LSU students will provide an additional 48.00 per semester for the maintenance and use of facilities. It's not clear if this applies to the students in the health sciences center.

Legislative Report- All campuses should prepare for mid year budget cuts. There is a shortfall of 15 million dollars for the 2015 budget. There are no more safety nets.

#### III. Accreditation

The health sciences center is up for its 10 year accreditation re-affirmation by SACSCOC (Compliance self-study documents are due by Sept. 2014; Quality Enhancement Plan is due a month or so later). The site visit will occur on March 24-26, 2015. The leadership

team (Mike Levitzky, Toni Cascio, Robin English, Janis Townsend, and Terry Ulrich) went to Atlanta to participate in the Reaffirmation Orientation.

Interprofessional Education is likely to be chosen as our Quality Enhancement Plan.
