 - a. Mandatory holidays
 - iv. Fair Labor Act
 - 1. No response in writing
 - 2. No confirmation, but hearsay is exceptions have been granted. All of program directors for GME would fall under this directive dispensation has been managed for that group of employees.
 - 3. Dual Test
 - a. How much money does employee make?
 - b. What are responsibilities?
 - i. Changing job description to 'supervisor' changes some things

- ii. Using Civil Service model
- iii. Student workers must use WebClock with no training offered at optimal times for students to attend
- iv. OT pay for physical hours worked, so if Labor Day was a holiday, get 8 hrs plus Tues thru Fri... for those who must show up on Labor Day (or another holiday, for animal care, lab, etc.) they must clock in and out on those days. Affects budgets.
- v. Juggling schedules for non-Monday-Friday schedules. Can have unintended consequences from a budgetary standpoint if not dutifully overseen.
- vi. Meeting with Department Heads with even 1 of 400 people affected by this rule:
 - 1. HR met with every person affected
 - 2. Terri Cunningham is HR director who met with all employees affected
- vii. Splitting of benefits over two monthly checks is occurring.

 - i. Credit for educational items through HSC
 - ii. Push in medical school to update P&T tracks to include an educator track
 - 1. Support within HSC from multiple school to revise criteria for current P&T guidelines
 - 2. Include QEP, IPE, education and service that in the past has not accounted towards P&T
 - 3. Research track does not fit what is needed for basic educator to be promoted
 - a. Main outcome would be assist faculty in being recognized by publishable material resources
 - b. All tracks come from PM 23 (permanent memorandum) which would need to be justified all the way up to the president of the University system
 - c. With independent campus, can change criteria within HSC with overall positive support
 - d. Senators Levitzky and Winsauer to circulate what was previously drafted by SOM
 - e. Would take pressure off P&T committee to fit candidates into criteria they do not fit into
