## Welcome

**Invited Guest:** Chancellor Hollier and Louis Colletta addressed questions submitted by the senate.

Regarding new leadership positions: There were 4 candidates for the VCAF position, 2 were interviewed. Search committee selected Keith Schroth. The search for the Dean of the School of Dentistry is open for applications through November 17<sup>th</sup>. There have already been 9 applications and 3 interviews. There was one applicant for the Director of Human Resources and one applicant for Chief of Staff. The Assistant Vice Chancellor for Academic Affairs position search has been postponed.

Regarding pending lawsuits: Office of Risk Management is involved and there is no cost to the university

Hurricane Zeta response: There were different responses from different parts of the city that were considered when making the decision to remain open the day after Hurricane Zeta. Special Leave was offered as an option for those that needed it.

CSRB entry: Need to reduce traffic into the building for now.

Cleaning: High traffic areas are still being cleaned but they have reduced some areas due to cost and data showing COVID is spread less through contact and more through inhalation.

Lions Center 1<sup>st</sup> floor: intent to lease space, one group interested in space for high-volume COVID testing
