Welcome and call to order by President McCauley at 3:34PM

In accordance with the Louisiana Constitution, Article 12, Section 3, and La. R.S. 42:11-28, the Faculty Senate Meeting for the Louisiana State University Health Sciences Center – New Orleans is hereby convened.

Guest Speakers:

Ben Lousteau and Jill Fragoso – Vice Chancellor of Administration and Finance; Chief Human Resources Officer

Update from Ben Lousteau:

- Communication is an important issue between VCAF and faculty. He will plan to attend the start of upcoming Senate meetings to provide updates and answer questions
- Chancellor Search
 - A meeting is scheduled between President Tate and Dr Steve Nelson for later this week. It is hoped there will be an outcome and announcement via press release soon.
- Media Liaison Gamble Company
 - o Gamble is currently being used for media relations due to Leslie Capo's retirement
 - They are conducting a full assessment of media needs which will likely lead to restructuring of the office
 - Due to the expense of utilizing Gamble, Ben is working to internally triage as many components as possible.
 - There is a need to build the name and reputation of LSU Health in addition to responding to media requests.
 - o Billboards are being updated and new content is needed.
 - Lamar company is the billboard contractor, and we can provide content to the changing billboard.

- Ben would like schools to send content to post. This can include internal and external clinics, Pathway programs in the School of Medicine, and any other content that helps build our image.

Update from Jill Fragoso:

- Parental Leave update
 - It has been enacted for classified staff and to use.
 - Initially, faculty and unclassified staff in higher education were not included in John Bel Edward's plan. LSU Baton Rouge campus has modified PM-20 and sent it through HR and Legal reviews. It is awaiting President Tate's signature, but he has not signed it yet. LSUHSC will piggyback off the Baton Rouge campus and enact it at the same time. It will be made retroactive to January 1, 2024.
 - Employees must be FMLA eligible to participate in the paid leave plan. This means that employees need to work at least 1 year prior to eligibility.
 - It will provide 6 weeks of paid parental leave for any gender parent who births/adopts a child.
 - The policy does not apply to Residents as they have their own leave policies separate from the institutional policies.
 - If someone needs to utilize it, they should contact HR. They can use sick time first and then apply for the 6 paid weeks.
- Progress since starting as HR Director approximately a year ago:
 - o Working on standardizing department structures
 - Utilizing recruiters to fill unclassified positions
 - Created a Talent & Development group
 - Offering In-Person new employee orientations for the first time in a long while
 - Offering leadership courses for both leaders and staff
 - Streamlined the process of hiring new people and greatly reduced the time required to go through it.

Questions/Concerns from Senators: Ben Lousteau will look into these items.

- Parking lot lights at Dental campus are not working in the evening or in the morning
- A parking lot at Dental Campus is not accessible due to being blocked by building materials. This is causing patients to be late for appointments.
- Sprinklers are coming on near CSRB during lunchtime and causing a disruption.
- Safety and security concerns at the CALS building include people gaining unauthorized access CALS, and also missing food and drink in kitchen and lounge areas.
- Ben indicated that overall, the space on campus is not being efficiently utilized, including student study spaces. He is working to put together a catalog of available spaces, so students are aware of their options.

Scott Embly - CAP (Campus Assistance Program) Slides from the presentation will be included with the minutes. Topics covered:

- Provided overview of CAP services
- 'Wellspot' Designation for LSUHSC-NO with the state of Louisiana
 - o Indicates we provide a healthy workplace
 - Includes an annual evaluation to maintain this designation
- Interactive Screening Program (ISP)
 - Tool available to all for depression screening
 - o **Confidential**
 - Available on the CAPS website
 - o Can be completed multiple times and a good resource to offer students
 - Can be completed by any LSUHSC affiliated person including faculty/staff/etc
- CAP services are mostly utilized via self-referral; 10-15% are administrative referrals
- Also provides the Drug Testing Program for new hires, reasonable suspicion, etc.
- Responsible Use of Alcohol Server Training is being offered at the Main Campus in March, June, and September. Dental Campus date is TBD. Contact ast@lsuhsc.edu for registration information.
- PALS resource fair is being held on 2/21/2024 for students to get information about various resources available on campus
- Spring Wellness Challenge will be held April 1-21

 - Focusing on Press Releases more than Marketing
 - \circ Consulting on how to build this department for future.

- Food Pantry
 - Meeting 4 weeks ago (this meeting)
 - Survey planned to Campus to determine needs
 - Financial Aid to Students, SNAP benefits
 - Vouchers vs. Physical Pantry
 - Farmer's Market with LSU-BR Ag Center
 - Need to contact Rouse's as they were helpful with setting up other institutional food pantries
- Student Health
 - Immunization Records has gone live
 - Director in place, staffing in progress
- Room Reservation System 25Live?
 - Need to account for room utilization (classrooms and meeting rooms)
 - Priority system is being planned to maximize efficiency
 - Schools will have some ability to control rooms in their primary locations

 - Drs Southerland and Nelson are supportive of this initiative;
 - Dr. Augustus-Wallace will meet with Dr. Southerland to move it closer to approval and rollout at our campus.
- Provide update from FS Handbook Committee -
 - Committee is formed and working asynchronously. Dr. Augustus-Wallace will provide an update later in this meeting and is aware of the timeline.
 - Major issues
 - Promotion of Residents/PostDocs to Faculty without an open job search
 - Definition of Ranks and consistent use:
 - Assistant Professor Clinical used for full time faculty
 - Clinical Assistant Professor of ____ used for Part time
 - Inconsistent for both
 - Educator Track is not popular at the BOR(?)
 - Define all tracks better
 - E.g. Resident vs Fellow
 - Senate needs to define all categories (Possibly next cycle?)
- Provide update regarding Moodle Support from LSU Online -
 - Contract is still being drafted as of 2/7 but should be complete after Mardi Gras.
 - Will forward to VCAA as soon as it is received. Dr. DiCarlo is concerned that new SOM database iSeek will have integration problems with LSU Online.
 - Update from President McCauley:
 - MOU has been sent to Drs Nelson and Southerland
